Under direction, coordinates the immediate and ongoing needs of victims of domestic violence, sexual assault, elder abuse, sex trafficking and other crimes against Alaska Native/American Indian women/men. Coordinates support for the victims and performs other work as required. The incumbent will lead the way by empowering victims of domestic violence, child abuse, sexual assault, and human trafficking to move from crisis to confidence. This position requires strict confidentiality and is victim centered. You may be required to testify in court proceedings against perpetrators of crime and as such you could find yourself in direct conflict with friends and family. Being able to separate friends and family from the job is critical in delivering the needed care to victims of crime.

Successful applicant must have the willingness to learn the policies, procedures, and operational guidelines that impact the judicial system in Alaska and Tribal Courts. Requires the ability to organize multiple projects, deal effectively with the public, communicate effectively both verbally and in writing, and work as a member of a group or independently.

QUALIFICATIONS:

- Justice related Associates Degree/Paralegal Studies Required. Active degree seeking students in Justice related studies acceptable. Records Management Training and HIPPA training REQUIRED.
- To be considered for employment, candidate must have taken and passed Online Victim Assistance Training (or similar) through Office for Victims of Crime and possess or have applied for Provisional Credential in Victim Advocacy through the National Advocate Credentialing Program (NACP).
