POSITION SUMMARY

The YTT Child Care Aide is an integrated position with the Yakutat Tlingit Tribe's Human Services Department. The Childcare Aide is responsible for assisting in the childcare program day to day operation by; providing, supervising, caring for and maintaining a safe and healthy curriculum based learning environment for children ages 0-12 years of age.

ESSENTIAL DUTIES AND RESPONSIBILITIES

The following duties are not intended to serve as a comprehensive list of all duties in this classification. Shown are duties intended to provide a representative summary or the major duties and responsibilities. The Childcare Aide may not be required to perform all duties listed and may be required to perform additional, positions specific duties:

- Assist staff with both long and short range activities in accordance with curriculum objectives, developmentally appropriate practice and program philosophy
- Maintain daily communication with parents
- Maintain confidentiality
- Report any suspected abuse to supervisor
- Document accidental reports
- Arrange a classroom environment in accordance to program goals and philosophy
- Maintain a safe and healthy environment.
- Inspect and replace damaged or lost materials
- Attend staff meetings
- Attend required trainings
- Keep all appropriate documents such as records, attendance and time sheets
- Meet applicable licensing regulations
- Perform other duties as assigned

MINIMUM QUALIFICATIONS

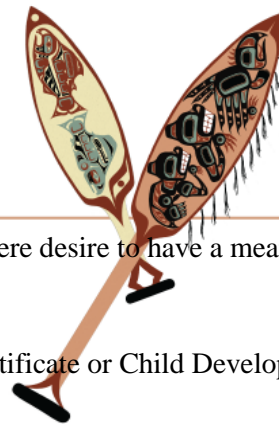
- High School Diploma or GED

- A commitment to working with children in a developmental setting and a sincere desire to have a meaningful effect on their lives
- Obtain First Aid/CPR Certification within 6 months of hire
- Obtain 12 semester hours in Early Childhood Development or Montessori Certificate or Child Development Accreditation
- Obtain OSHA Blood Borne Pathogen Certification within 1 year of hire
- Documentation that the individual is free from active Tuberculosis
